### South East Alaska Friends of Montessori (SEAFOM) Teacher Training Candidate 2019 Application

Our mission is to support schools and individuals throughout Southeast Alaska by promoting, developing, implementing, and maintaining Montessori education, as created by Dr. Maria Montessori.

SEAFOM provides funding to eligible individuals to obtain Montessori teaching certifications through the Association Montessori Internationale (AMI) at all levels: Assistant to Infancy (birth to 3 yrs), Primary (3-6 yrs), Elementary (6-12 yrs), and Adolescence (12-15 yrs). However, the 2019 funding priority is for trainings of Primary and Elementary levels. Candidates for training must be admitted into an AMI training center and must possess credentials for teaching in Alaska's public schools, or present an educational plan for achieving such licensing credentials.

SEAFOM teacher training awards are considered "sponsorships" and include a multi-year obligation from the funding recipient to diligently pursue employment (after training is complete) at an AMI-based Montessori school in Juneau or Southeast Alaska location. SEAFOM cannot guarantee the employment of teachers, but endeavors to prepare candidates who are committed to Montessori education and to living in Southeast Alaska.

The amount of funding and conditions of repayment (should the candidate not complete its obligations) vary with available funding. SEAFOM's funding priority is to pay for tuition associated with a training program. Funding for travel, fees other than tuition at an AMI training center, living expenses, and equipment/materials is not guaranteed, but may be granted by SEAFOM on a limited basis when financial need is demonstrated. The conditions of repayment vary according to the amount of funding provided by SEAFOM, with larger funding allocations being tied to longer repayment contracts. Repayment is only required if the candidate does not successfully complete the training, or does not accept an offered teaching position in an AMI-based school in their Southeast Alaska community.

SEAFOM retains all rights to allocate funding to candidates of its choice, and under terms of its discretion without regard to previous funding awards or other conditions.

- C. Schedule and conduct interviews (if needed) March 11 18, 2019
- D. Announce Scholarship Awards (subject to SEAFOM funding approval) no later than March 31, 2019

#### 2. Criteria for Candidate Selection:

- A. Must be a SEAFOM member at the time of application.
- B. Must apply to an AMI training center at the time of submission of this application (unless a delayed AMI training center application is approved by SEAFOM President prior to 3.1.2019).
- C. Must hold a State of Alaska Teaching License or demonstrate a plan to obtain such (except for A to I candidates).
- D. Must show ongoing commitment to working with children and families, and to Montessori education through work experience, volunteer efforts, etc.
- E. Must have outstanding personal integrity/ethics and personal responsibility.
- F. Should be a current resident of Juneau or other SE Alaska community, with intention to live and work in Juneau or SE Alaska location with AMI-based Montessori School.
